Furry Friends Freedom Foundation ("4F") operates on a foster to adopt basis. By signing this agreement you agree to hold this foster pet for the entire week. You will not take it to a vet without prior consent of a "4F" representative. If you take this pet to an unapproved vet, you will be responsible for the medical costs. "4F" will pay prior approved medical costs for up to two weeks from original foster date. The rescue has the right to approve or deny any costs associated with said pet. You agree to let a "4F" representative know by email or phone no later than Friday 9:00pm if the pet will remain with you for further foster / adoption or if you will be returning the pet to the rescue. Fosters must be brought to the designated adoption site weekly by 10:00am unless prior arrangements have been made. If you choose to adopt the pet, you must alert a "4F" representative as soon as possible. This decision must be made within two weeks of the original foster date. After two weeks, the pet is considered adopted and all medical bills and / or liability associated with said animal is your responsibility. 4F does ask an adoption fee in order to help us cover expenses incurred. Anything received above that amount is a tax-deductible donation. You agree to come to the designated adoption site to finalize the adoption and pay the adoption fee. If unable to come to the adoption site, a check / money order made payable to Furry Friends Freedom Foundation for the adoption fee will be mailed to the above address.

All of the above information I have given is true and complete. This dog will reside in my home as a pet. I will provide it with adequate food, water, shelter, training, affection, and medical care. I understand that "4F" is an animal rescue and is not responsible for the accuracy of information received about the habits, temperament, or physical condition of dogs available for adoption. I understand that it is my responsibility to evaluate the dog for myself before agreeing to adopt it. I am in full agreement with these terms of adoption.
